Person type	Maximum retention timeframe	Legal basis for retention
Customers	Customer lifetime + 2 years	As a waste transfer company, by law required to retain records pertaining to the transfer of waste. Read the government overview https://www.gov.uk/managing-your-waste-an-overview/waste-transfer-notes
Suppliers	Supplier lifetime + 6 years	https://www.gov.uk/vat-record- keeping
Employees	Employee employment lifetime + 5 years	http://www.hse.gov.uk/ foi/busclasschem.pdf
Recruitment candidates	2 years	Recruitment records can be retained for as long as there is a clear business need. 2 years allows the company to re-contact any previously unsuccessful candidates with new job opportunities. https://www.gov.uk/data-protection-your-business/recruitment-managing-staff-records
Enquiries	2 years	The company sees a clear business need to retain enquiry contact information for a period of 2 years to ensure a streamlined approach to re-enquirers.
